#### **Order Placement**

#### Installation

Installations in our Next Business Day Service Area occur Monday to Saturday. Those in the Expanded Service Area occur on Tuesdays and Fridays.

## Sign Placement

In general, we have a policy of not installing signs on the city boulevard, which refers to the grassy strip between the sidewalk and the road. This is because most municipalities prohibit the placement of temporary signage on city property. Violating this rule may result in fines imposed by the municipality, and in some cases, the municipality may confiscate the sign without prior notice. If we are unable to retrieve our sign post from the city, you may be subject to a charge for the missing post, in addition to any fines imposed by the municipality.

Similarly, it's important to note that most condominium corporations have specific guidelines outlined in their by-laws regarding the placement of signs on condominium property. We strongly advise you to consult with the condominium corporation and/or your seller to determine the permitted signage. When requesting an installation, especially in a condominium or townhouse complex, please provide clear instructions on the desired sign placement.

Please be aware that Movetto Inc. does not assume responsibility for ensuring compliance with local city by-laws or condominium corporation by-laws regarding the placement or location of real estate signs.

Any charges incurred, including, but not limited to, fines imposed by the municipality or condominium corporations, as well as any loss of Movetto property, will be the responsibility of the agent.

#### **Damaged or Unrecoverable Posts**

The agent assumes responsibility for the sign post used at their listings. In the event of severe damage or non-recovery of the post, a charge of \$135.00 will apply. Additionally, if the post incurs damage due to stickers or attachments installed by the agent, a repair/repaint charge of \$20.00 will be applicable.

## Billing

An itemized invoice will be generated for your office at the end of each month. This invoice will be paid on your behalf and reflected in your monthly office statements.

## Storage

To ensure prompt and efficient service, we can store your signs in our warehouse. Although the utmost care is taken when storing your signs, reasonable wear and tear, such as minor fading over time, is to be expected.
